2. Discuss approval to purchase internet connectivity equipment to be used in the sheriff’s mobile command/community engagement vehicle. Tabled from the 911 meeting on 11-25-2025. (911 meeting for Tuesday, December 9, 2025)
3. Discuss rescinding the item from 11-6-2025 on Dan’s report related to relocating the hangar onto the arena property.
4. Discuss BUILD grant related to Hwy. US 411.
5. Discuss a contract with Precision Claims Management Group, LLC., (PCMG, LLC) to provide inmate medical claim cost reduction services, pending the county attorney’s review.
